- An email was received from the Clerk of Bransgore PC on 30<sup>th</sup> March, confirming that the Lengthsman Scheme will continue in 2016/17. The Clerk of BPC has registered an account to be able to report on problems and record work done on public Rights of Way.
- An email was received on 5<sup>th</sup> April, from HCC, stating that the current bus timetable will run 10 minutes later from the week commencing 29<sup>th</sup> May 2016. From 2<sup>nd</sup> September the service will continue to operate but with a reduced operating pattern: the current 3-day service will stay in place until Friday 2 September but from Monday 5<sup>th</sup> September 2016 it will reduce to a 2 days per week service, coinciding with the proposed award of the new tender. HCC are inviting parish councils to submit their preferred two days of operation by **Friday 6 May 2016**.
