**Wessex Internet** Vicky Missen from Wessex Internet reported that the cause of the initial delay of the fibre broadband project in Burley was inclement weather holding up the schedule of their previous fibre broadband projects. Wessex Internet are now in talks with Natural England and Forestry England to gain permissions to cross the forest with their infrastructure. Delivery in Burley is expected in the early part of 2026. Wessex Internet will be available to chat to at the Burley Village Show on Saturday 2nd August from 12.30pm in
