War Memorial appeal: The Burley Village War Memorial was presented to the village and erected in 1920 by Colonel and Mrs Willan of Burley Manor, as a token of their gratitude to God for the preservation of their two sons and a son-in-law, all of whom served in France during the First World War. Burley Parish Council is responsible for the upkeep of the War Memorial and uses a fund, raised by public subscription, to maintain it. This fund has now been exhausted.
